- *Providing parents frequent progress reports and reasonable access to staff to communicate questions or concerns.*
- *Provide opportunities for parents to volunteer and participate in their child's education.*
- *Provide opportunities for parents to participate in school improvement (e.g. LSIC)*

PARENT RESPONSIBILITIES: We, as parents, will support our child's learning by:

- *Communicating with school administration and teachers if questions or concerns arise during the school year.*
- *Encouraging faithful attendance and avoiding unexcused absences and tardiness.*
- *Ensuring assignments and/or homework is completed.*
- *Encouraging and supporting positive behavior.*
- *Volunteering in my child's classroom or at school events.*
- *Participating, as appropriate, in decisions relating to my child's education.*
- *Attending Open House, Parent-Teacher Conferences, and other school related events.*
- *Staying informed about my child's education and communicating with the school by promptly reading all notices from the school or the school district either received by my child or by mail and responding, as appropriate.*
- *Serving, as reasonable, on committees and advisory groups (e.g., LSIC)*
- *Accessing school-wide communication applications (e.g. school website, ALL E-Learning sites such as Schoology, etc.).*

- *Reading at least 30 minutes every day outside of school time.*
